DRAFT REPORT OF THE FOURTEENTH SESSION OF THE IPCC BUREAU

Maldives, 21 September 1997

- 1. The session was declared open by the Chairman of the IPCC, Prof. B. Bolin, at 0930 hours on Sunday, 21 September 1997, in Bandos Island, Maldives. The agenda as adopted is attached in Appendix A.
- 2. The draft Report of the Thirteenth Session of the Bureau was amended as follows and approved.
- a. A new paragraph 3.2 was added to read:
- "A number of governments had made nominations for membership in the IPCC Bureau, scheduled to be elected at the Thirteenth Session of the IPCC, or had signaled their intention to do so. This information was made available to the Bureau (see Appendix B for a listing of communications from governments)."
- b. The old paragraph 3.2 was renumbered as new paragraph 3.3.
- c. Paragraph 5.1 was amended to add a new 5th bullet reading:
 - "welcomed the offer of the Government of the Netherlands to host the Workshop on Rapid Non-linear Climate Change from 31 March to 2 April 1998, agreed that the proposal should be carried forward to the Thirteenth Session of the IPCC and further agreed that the Netherlands could in the interim start preparations to organize this workshop;".
- 3. The Co-Chairmen of Working Group I informed the Bureau of the revisions made to

the draft Technical Paper, Implications of Proposed CO₂ Emissions Limitations by the Lead Authors in the light of the comments received during final government review. In its capacity as the editorial board for the Paper, the Bureau considered those major comments that the Lead Authors had not fully incorporated in the revised draft and expressed satisfaction that the Lead Authors had observed the agreed Procedures. In the light of its observations, the Bureau requested the Lead authors to finalize the draft Technical Paper. The Bureau decided that the Technical Paper should be made available to the Subsidiary Body for Scientific and Technological Advice (SBSTA) of the Conference of the Parties to

the UN Framework Convention on Climate Change, and thereafter publicly, as soon as possible after finalization by the Lead Authors.

4. The Bureau considered the revisions made by the Chairman-Elect, Dr. Robert T. Watson, to the draft Decision Paper on the Third Assessment Report (TAR), as requested at the Thirteenth Session (Geneva, 9-11 July 1997). It agreed that the Chairman-Elect should present the revised version to the IPCC at *its* Thirteenth Session (Maldives, 22 & 25-28 September 1997).

5. The Bureau was informed

- a. that the draft Special Report on Regional Impacts of Climate Change: An Assessment of Vulnerabilities would be submitted to the Fourth Session of Working Group II (Maldives, 23-24 September 1997) for action;
- b. that the Special Report on Emissions Scenarios would be completed in late 1999;
- c. that the chapter outlines for the Special Report on the Methodological and Technological Aspects of Technology Transfer had been agreed to by the Coordinating Lead/Lead Authors;
- d. that the completion date for the Special Report on Aviation and the Global Atmosphere had been rescheduled for the first half of 1999;
- e. that the Task Group for Regional Climate Change Scenarios would be recommending the location for the Data Distribution Centre based on the responses received from governments to the circular letter on the subject;
- f. that the results of the IPCC Workshop on Economic Impacts of the Actions of Annex I Parties on All Countries (Oslo, 18-20 August 1997) could feed into the TAR;
- g. that the report of the Denmark workshop on costing methodologies would be published by UNEP;
- h. that the Revised 1996 IPCC Guidelines on National Greenhouse Gas Inventories had been published.
- 6. The time and place of the next session of the Bureau would be announced after the election of the new Bureau.
- 7. The session closed at 1830 hours on Sunday, 21 September 1997. The list of attendees is attached in Appendix C.
