I. INTRODUCTION

The Sixty First Session of the Intergovernmental Panel on Climate Change (IPCC) will take place in Sofia, Bulgaria from 26 July to 2 August 2024.

Bulgaria, a country occupying the eastern portion of the Balkan Peninsula was founded in the 7th century. Bordered by Greece and Türkiye to the south, Serbia and North Macedonia to the west, and Romania to the north, Bulgaria is one of the oldest states on the European continent. It covers a territory of 110,994 square kilometers and is the 16th largest country in Europe. Sofia is the nation's capital and largest city; other major cities include Burgas, Plovdiv, and Varna. Bulgaria is a member of EU since 1 January 2007.



The meeting will take place at the "Grand Millenium Hotel" in Sofia.

III. VISITORS TO BULGARIA

1. INTERNATIONAL AIRPORT

Participants are recommended to arrive at Sofia airport. Sofia Airport is the main international airport of Bulgaria is located 10 km east of the capital Sofia. The airport currently serves more than 7 million passengers and is easily accessible from all major international hubs.

2. TRANSPORTATION

Participants will be responsible for coordinating their own transportation to and from the airport. Please consult the <u>airport website</u> for more information, including transportation facilities.

TRANSPORT FROM/TO SOFIA INTERNATIONAL AIRPORT

METRO

Sofia Airport Metro Station is in close proximity to the airport terminal building 2. The line provides a transport connection to the city centre and to the large residential complexes. The journey time from Sofia Airport to the city centre is approximately 18 min.

Trip to the venue from Sofia airport takes approximately 40 minutes via the metro. Delegates can arrive at the meeting venue from the airport by making one quick switch at Serdika station to Line 2 for one more stop to National Palace of Culture (NDK) station.

CAR/TAXI

The distance from the airport to the venue is about 13 km and takes approximately 25-30 minutes (depending on the traffic). Taxis are available outside arrivals of both Terminal 1 and Terminal 2. It is recommended to only take yellow Taxis located outside the terminal.

3. TIME ZONE

Bulgaria is UTC +0200 hours.

4. VISAS FOR TRAVEL TO BULGARIA

A valid entry visa is required for most nationals and needs to be obtained in advance.

6. WEATHER

Bulgaria has a wide variety of climate types.

During July, you can expect temperatures that range from warm to very warm and precipitation levels ranging from moderate to high. Various regions within the country however, influenced by geographical factors like mountains and proximity to the Black Sea, experience their own unique microclimates. These can be totally different from the typical temperate conditions.

7. CURRENCY

The currency in Bulgaria is the Bulgarian lev. Each lev is divided into 100 stotinki.

The currency code currency for Bulgarian Lev is BGN. Once you're in Bulgaria, you'll see the symbol лв used to show prices. Banknotes are in denominations of 5, 10, 20, 50 and 100. There are also 1 lev coin and 2-lev coin.

The current exchange rates are:

1 USD = Lev 1.80 1 EUR = Lev 1.95

Please note that these rates can vary with time and with the agent exchanging currency. Please check www.xe.com for the most up-to-date exchange rates.

Foreign currency can be changed at banks, foreign currency exchange bureau or at hotels. Banks in major centers are open from 09.00 to 17.00 Monday to Friday.

ATMS are available country-wide with 24-hour access.

Credit cards

Major international cards are accepted.

Tipping

It's normal to tip for good service in restaurants, bars and cafes in Bulgaria - especially in touristy or business areas. Tips are also appreciated in hotels and serviced apartments - and other places where staff may provide services. The amount you tip in Bulgaria will depend on where you are and what type of services you're buying. As a general rule, expect to tip around 10% of the bill. If you get exceptionally good service, you closer to 15-20%.

8. ELECTRICITY

Power systems are 220 volts and 50 Hz.

Participants are advised to bring their own plug adapters to plug into power sockets. The type of plugs and sockets found in Bulgaria are $\underline{\text{type } F}$.

- (1) Citizens of the EU, EEC (Norway, Iceland and Lichtenstein) and Switzerland are exempted from the requirement to have a long-term visa and from the requirement to have "work permit" when staying in Bulgaria for the period of more than 90 days.
- (2) Citizens of the Republic of Turkey holding valid regular passports and visas issued by the Member States of the Convention implementing the Schengen Agreement or of the European Union, or residence permits issued by the Member States of the Convention implementing the Schengen Agreement or of the European Union, Switzerland or Liechtenstein, may enter the territory of the Republic of Bulgaria and transit there through without visas for up to 5 (five) days, when their transit is from the Republic of Turkey to the state which issued the visa or residence permit, as well as in case of transit from such state to the Republic of Turkey. Nationals of Turkey, holders of special passports are not visa exempt.
- (3) Only holders of biometric passports are exempt from the visa obligation. Holders of non-biometric passports still require a visa in which case the visa facilitation agreements apply. The exemption from the visa requirement should apply only to holders of biometric passports issued by Kosovo in relevance with the provisions of Regulation (EU) 2023/850 of the European Parliament

and of the Council of 19 April 2023 amending Regulation (EU) 2018/1806 listing the third countries whose nationals must be in possession of visas when crossing the external borders and those whose nationals are exempt from that requirement.

(4) Only holders of biometric passports are exempt from the visa obligation. Holders of non-biometric passports and holders of passports issued by the Serbian Coordination Directorate (in Serbian: Koordinaciona uprava) still require a visa in which case the visa facilitation agreements apply.
